Statement to the Carabobo community in the face of the Coronavirus (Covid-19) health emergency and the manifestation in five states of the Republic of the Brazilian variant P.1 of SARS-CoV-2.

OFFICIAL NOTICE

JESÚS ALBERTO PARIS LARA, GENERAL SECRETARY OF THE GOVERNMENT appointed by Decree No. 1624, published in the Official Gazette of the Carabobo State, Special Issue No. 8096, dated December 30, 2020 and ratified by Decree 1645, published in the Official Gazette of the Carabobo State, Special Issue No. 8117, dated January 29, 2021 in accordance with the provisions of article 62, numeral 22 of the Law of Reform to the Act of Organization of the Public Administration of the state of Carabobo, informs the Carabobo community of the following:

STATEMENT

1. In adherence and strict compliance with the guidelines and directives decreed by the Executive Branch on March thirteenth (13), 2020 through Decree No. 4,160 and the decree of controlled relaxation with a sanitary fence in the Capital District and the states of La Guaira, Miranda and Bolívar, by virtue of the appearance of the Brazilian variant P.1 of SARS-CoV-2, the owners, representatives and / or managers of commercial establishments such as supermarkets, convenience stores, corner shops and restaurants that sell basic necessities, food, supplies to process food, prepared food, among others, are urged to guarantee to its workers and personnel of all kinds who work in them, the strict use of face masks, masks, gloves, as well as the necessary clothing that contributes, directly and indirectly, to prevent the spread of said virus, in order to comply with the prevention mechanisms of the virus; in the same way they must monitor and guarantee that citizens, customers and users in general who go to this type of establishment have such clothing.

2. In the context of the present situation, a call is made to CANCELLATION as of this date, of all activities related to public and private events, mass gatherings of people, sport events that have not been authorized by the appropriate authority, cultural, promotional, and other activities of a special or continuous nature, scheduled or not, as well as the absolute suspension of all kinds of events and public festivities dependent on the State Executive of Carabobo.

STATEMENT

3. The regional governing body in health matters, the Carabobeño Health Institute Foundation (INSALUD), and other hospitals and primary health care centers, as well as the security, civil protection and emergency bodies, are urged to carry out the actions aimed at ensuring the observance and strict compliance with the prevention and quarantine protocols issued by the national government to attend to the emergency in the health system, both public and private, in the jurisdiction of the state of Carabobo. In this sense, as primary agents and executors of the aforementioned health measures, the officials of the aforementioned public systems are urged to take the precautions and measures strictly necessary so that in the exercise of these benefits activities under their responsibility, they safeguard their health.

4. The authorities and other officials of the Autonomous Institute of Airports of the Carabobo state are urged to ensure strict compliance with the guidelines and directives of the Executive Branch in matters of transport and air cargo. Likewise, the municipal authorities are urged to take the necessary preventive and biosafety measures to safeguard the integrity of users and workers in the public transport sector and land terminals within the scope of their powers.

5. The Municipal Public Entities of the Carabobo state jurisdiction are urged to enact and establish the necessary measures in relation to the exercise of economic and recreational activity, in execution and strict adherence to the Presidential order through which the Bolivarian Republic of Venezuela is declared in a "Permanent State of Emergency", in the framework of the World Pandemic due to the Coronavirus (COVID-19) and the manifestation in the country of the Brazilian variant P.1 of SARS-CoV -2, for its prevention, protection and preparation.

STATEMENT

6. A call is made to the conscience of the hierarchical authorities of the different religions, worship and other unions that make life in society within the jurisdiction of the Carabobo state, to avoid mass concentrations and acts of a religious or other nature, in order to comply with the health protocols established by the different competent bodies in the matter, and in this way prevent the spread of the COVID-19 virus (coronavirus) and the Brazilian variant P.1 of SARS-CoV-2, which has already appeared in our country.

7. The Carabobo community in general is urged to take conscious, supportive and responsible measures to contribute in a participatory and leading way in the protection of the measures corresponding to the prevention of the spread of the COVID-19 virus (coronavirus) and the variant Brazilian P.1 of SARS-CoV-2 already present in our country.

8. The competent authorities in matters of citizen security and comprehensive defense of the nation are urged to monitor and strictly comply with the guidelines and directives decreed by the Executive Branch on March thirteenth (13), 2020 through Decree No. 4,160 within the scope of its powers.
