**ADMINISTRATIVE RULING SATDC-DS-2021 N ° 002** dated February eight (08) of the year two thousand twenty-one (2021), through which the amount corresponding to the value of the CAPITAL DISTRICT TAX UNIT (UTDC) is READJUSTED, to FIVE MILLION THREE HUNDRED FIFTY-SIX THOUSAND BOLÍVARES AND ZERO CENTS (BS. 5,356,000.00)

**ADMINISTRATIVE RULING SATDC-DS-2021-N° 002**

In accordance with what it is provided by Article 1 of **Decree No. 055** by which the Tax Unit of the Capital District (UTDC) is established within the jurisdiction of the Capital District, published in the Official Gazette of the Capital District No. 668 dated January 11, 2021, the amount corresponding to the Value of the Tax Unit of the Capital District is published by means of this administrative act, which will come into effect as of February 8, 2021, equivalent in bolivars to **FIVE MILLION THREE HUNDRED FIFTY-SIX THOUSAND BOLIVARS WITH ZERO CENTS (5,356,000.00 Bs.)**

The Tax Unit of the Capital District (UTDC) represents the value of ONE POINT SEVEN PERCENT (1.7%) of the value of the fluctuating crypto-asset PETRO, created by Decree No. 3,196, published in the Official Gazette of the Bolivarian Republic of Venezuela N ° 6,346 Special Issue, dated December 8, 2017, established by the National Superintendence of Crypto Assets.

The value of the Tax Unit of the Capital District (UTDC) will remain in force until the Tax Administration of the Capital District, as provided by Article 5 of the aforementioned Decree published in the Official Gazette of the Capital District, or any other measure established by the Organic Tax Code make adjustments to said value.

De conformidad con lo establecido en el artículo 4 del Decreto N°053 mediante el cual se establece la Unidad Tributaria del Distrito Capital (UTDC) en el ámbito de la jurisdicción del Distrito Capital, publicado en Gaceta Oficial del Distrito Capital N° 668, de fecha 11 de enero de 2011, se procede a publicar mediante el presente acto administrativo el monto correspondiente al Valor de la Unidad Tributaria del Distrito Capital que entra en vigencia a partir del 08 de febrero de 2021, equivalente en bolívars a CINCO MILLONES TRESCIENTOS CINCUENTA Y SEIS MIL BOLÍVARES CON CERO CÉNTIMOS (Bs.5.356.000,00 Bs.).

La Unidad Tributaria del Distrito Capital (UTDC), representa el valor del UNO COMA SIETE POR CIENTO (3%), del Origen activo PETRO FLUCLUANTE, creado mediante Decreto N° 3.126, publicado en Gaceta Oficial de la República Bolivariana de Venezuela Extraordinaria N° 6.146, de fecha 8 de diciembre de 2017, establecido por la Superintendencia Nacional de Crecimiento Económico.

El valor de la Unidad Tributaria del Distrito Capital (UTDC), se mantendrá vigente hasta tanto la Administración Tributaria del Distrito Capital, según lo dispuesto en el artículo 5 del presente Decreto, publicado en Gaceta Oficial del Distrito Capital o cuantos en otro medio que establezca el Código Orgánico Tributario ajuste a dicho valor.
